

**Curriculum of the Legal Specialisation in Comparative Intellectual Property Law
degree programme**

1. Prerequisites for obtaining the qualification

1.1 Prerequisites for obtaining the qualification of the Legal Specialisation in Comparative Intellectual Property Law degree:

Obtaining pre-degree certificate:

- acquiring at least 60 credits aligning with the plan of the programme

Successfully passing the final exam

- thesis defense
- successfully passing the final exam

1.2 In addition to this training plan, the following shall apply to the method of obtaining the qualification and other conditions for obtaining the qualification: the qualification requirements for the training shall be governed by the other applicable legislation in effect at the time [in particular Act CCIV of 2011 on National Higher Education], the study and examination regulations and other regulations of the University and other regulations of the Faculty.

2. Earning credits and their sources

a. earning credits

For the Legal Specialisation in Comparative Intellectual Property Law degree plan, the 60 credits must be obtained from the following sources, as indicated below.

3. Rules for taking and completing certain subjects and study obligations

a. Main subjects

i. For main subjects, the semester in which the subject is announced is the semester in which the subject is announced by the department/institute with lectures or by a separate practical lesson with attendance teaching.

b. Lecture

i. A frontal teaching format for a large group of students, culminating in a colloquium. The relevant institute/department organizes a lecture on the subject in question, during the general phase of the subject and then per module. Attendance of the lecture is not compulsory but strongly recommended.

c. Practice

- i. Completion of the practicals is compulsory to obtain credit.
- ii. Practice: typically, in small groups, where the student is required to work independently. The practical grade is used to assess student performance.
- iii. Attendance at the practice sessions is compulsory.

d. Compulsory elective subjects

University of Szeged Faculty of Law and Political Sciences

i. The elective subjects can be completed from among the elective subjects accredited by the Faculty Council and announced in the semester under the conditions specified in the semester's syllabus.

e. Thesis

i. The thesis must be at least 2 author sheets (80,000 characters), including footnotes and a table of contents in addition to the main body of the thesis. The internal title page, bibliography, annexes, appendices, pictures, maps and figures are not included in the length of the thesis.

ii. The academic prerequisite for the submission of the thesis is the successful completion of all the examinations specified in the training plan.

iii. If the student does not submit the thesis after the award of the pre-degree certificate, he/she will not be allowed to start the final examinations. The thesis may be handed in within the time limit for final examinations, as laid down in the Nftv.

4. Final exam

4.1 To be admitted to the final examination, you must have obtained a final certificate (pre-degree certificate). The final certificate is issued by the higher education institution to students who have fulfilled the study and examination requirements set out in the curriculum, with the exception of the thesis, and who have acquired the required credits.

4.2 Results of the final exam

1. Results of the thesis defence

2. The result of the complex examination, consisting of four modules, is determined on the basis of the arithmetical average of the marks awarded, provided that the student has obtained at least a pass mark in each module.

Specific areas of study in the Legal Specialisation in Comparative Intellectual Property Law degree programme: 1. International and European copyright law; 2. International and European industrial property law; 3. Economics of intellectual property protection; 4. International trade law and intellectual property protection.

The result of the final examination is the arithmetical average of the two marks in 1 and 2.

5. Calculation of the final GPA

1. Results of the final examination
2. Grade calculated as the average of the marks for all subjects.

The diploma mark is calculated as the simple arithmetic average of the marks for the above two elements, according to the rules of rounding.

6. Other provisions

- 1, The Dean or the Associate Dean for Education issues a recommended curriculum for students, within the framework of the study plans, with a number of credits per semester between 27 and 33, taking into account the prerequisites for study.
2. A student may take up to 45 credits of subjects in a semester. Additional credit may be granted by the Academic Committee, on a case-by-case basis, if justified.
3. This training plan is applicable from the first semester of the academic year 2024/2025.
